The VCA and EJC Boards of Directors held hybrid in-person/virtual Board Meetings on Tuesday, February 22, at 6:30 p.m. in the Starpointe Gallery Rooms and via Zoom. As there was no actionable business to discuss, the ECA Board Meeting was cancelled.

Among other topics, the VCA Board

certified the slate of candidates running for the VCA Board in the upcoming

March election (see below for more information), and the EJC Board approved an updated charter for the Budget Finance Committee and appointments to the Landscape Committee.

Developer Update and Meeting Reminder

The EMR ownership has applied to the City of Goodyear to amend the Montecito Planned Area Development (PAD) to change the residential district designation for Parcels 9.18, 9.21, and 9.42 from SFD-60 to SFD/A, and for Parcel 9.7 from SFD-60 to SFD-50. This amendment would maintain Montecito's overall maximum density but allow for the development of 50'- and 47'- wide lots on four undeveloped parcels where 60' is currently the minimum lot width. The amendment would also align the timing for development of a 12-acre park on Parcel 9.23 to match the timing of the surrounding development.
